- **C.** Adoption of Agenda (Ashlee) Leni motioned and Kristin seconded.
- **D.** Approval of Previous Minutes from November 20, 2024- will be moved to next month's meeting (Ashlee)
- E. NCG Reports
  - 1. NCG Financial Report (Mat)



- **a.** New and renewed sponsors- Leni, Tyson, Sac Probation, and Jasjit with SCUSD all renewed as annual sponsors. Tumblebuddies and Nicole Dunlevy are in-kind sponsors again. Sac Pack and Ship is a new annual sponsor.
- b. NCG account balance- \$2,781.53
- **c. Expected expenses in 2025 calendar year-** Leni motioned to move to next month's agenda. Ashlee seconded. Motion passed.
- **d. 501(c)(3) Annual filings** Preparing annual reports such as raffle summary, along with raffle application for the 2025 year.
- e. Treasurer report received and filed.

## 2. NCG Membership Status (Kristin)

- a. 4 new members since November board meeting. This puts membership at about 260 total.
- b. Board will brainstorm ideas to increase membership and bring those to the February board meeting.
- c. Membership report received and filed.

### F. Non-NCG Reports

#### 1. Neighborhood Schools (Cash)

- a. Bancroft- started incoming kindergarten tours, with a second tour on 1/27 at 8am. Contact the school to sign up. TK and kindergarten registration is happening now and can be done online.
- b. CMP- campus tours beginning 1/16 through 3/27. You can sign up online.
- c. Umoja- UC Davis student law program is sponsoring a day of community service. 50 volunteers are coming to clean up the school. Volunteering begins at 8am.
- d. Miwok- recently had 7 students accepted into Capitol Section Honor Bands. The honor bands performed last weekend at the Performing Arts Theater at Consumnes Oaks High School.
- e. Rosemont- two coaches named Sierra Valley coach of the year.
- f. Rio Americano- girls wrestling team is undefeated with one remaining dual this season. Their PTSA is hosting a Texas Hold Em Poker night on 3/29. Tickets are \$75 and on sale now.
- 2. Neighborhood Sports Leagues (Matt)- no updates
- 3. Folsom Boulevard Coalition (Linda) no updates
- **4.** Sacramento Police Department (LT. Todd Bevins)- Crime report: For the last two weeks, in all of the CG area, only one stolen car and one car broken into. Leni asked if they receive data on "porch pirates." LT. Bevins



said they get calls for service on package theft but a lot of people don't even call. The police department doesn't have a specific category for package theft, so it's lumped into petty theft. LT. Bevins suggests scheduling packages for designated times, or asking for packages to be placed behind a gate, etc. Sac PD now uses new metrics for crime. There used to be multiple crimes in a single report and now they classify each crime as a separate report with its own event number. They pull by event number, so there are multiple event numbers now assigned to one event. Leni requested a roll call in late February or March.

- 5. California Assembly Report (Maggy Krell)-no updates
- **6. Sacramento City Council Report (Councilman Eric Guerra Representative)** City Council did not extend City Manager contract in December so he resigned and the City Council has appointed the Assistant City Manager in the interim. The city anticipates there will be a 6-8 month period of putting out a nationwide and internal search for candidates. Leni asked how the city's subcommittee for Streets for People collecting is using the data it collected on how to create safer active transportation on Howe Ave. The data is being used and collected. Kristin asked about staffing at Guerra's office- there are currently 6 staff in office. A member of the public asked about parking under Howe underpass- parking will be allowed on both sides.
- **G. Public Comment (Brown Act § 54954.3)** This segment of the agenda is reserved for members of the public to directly address the NCG Board on any matters within its jurisdiction. A time limit of two (2) minutes per speaker and ten (10) minutes per topic will be allotted. No action may be taken during this time. NCG may briefly respond to comments made or questions posed. For an item to be placed on a future agenda, please contact the NCG secretary.
- **H.** Information Items (*Items not to be voted on*)
  - 1. Holidays in CG Recap (Ashlee/Mat)- Really good numbers for the book sale and CMP is interested in participating again next year. California International Marathon (CIM) was a potential detraction because of traffic. We'll need to plan for that next year.
  - **2. Neighborhood Events (All)-** Cabana Polar Plunge fundraiser is upcoming. CGLL opening day is March 8th.
  - 3. NCG Business Map (Leni) -We currently have 9 annual sponsors, with possibly 2 more signing on. As a way of saying thank you, Leni will be making a video about each sponsor and posting once a month to social media. She visited Sac Pack and Ship yesterday and also had conversations with other businesses in the neighborhood that already give to other community-based organizations. Informed them they can



be involved by donating \$50 and be placed on a CG business map which will be posted to social media intermittently. Interested businesses should email <a href="mailto:businessrep@NCG.org">businessrep@NCG.org</a>. The business map will be ready in February.

- **4. NCG Board Meeting Format/Location (All)-** Moving to Peet's coffee at Raley's, beginning in February. NCG will ask about bike parking during the meeting because Raley's does not have a designated bike parking spot.
- **5. 2025 NCG Community Calendar-** will be creating with NCG signature events and other community events.
- 6. Folsom Blvd Project Development Plans (Kristin)
  - **a.** Gas Station/Liquor store are- redid plans with proposed changes made (reduced number of buildings/apartments)
  - **b.** New plan does include some privacy screening for Everglade residents.
  - c. NCG emailed the project manager reiterating some of concerns from the neighborhood regarding privacy, mitigating the influx of new residents and increased traffic. May also lead tinto increased need for services like 311 bc more people, etc. NCG will post our email on the website, along with the rest of our advocacy letters.
  - d. Comment period ends 1/24/25
- I. NCG Board meeting format/location- Andie motioned to change the meeting format/location. We will maintain the same time, same date. Ashlee seconded. All in favor. Motion carries.
