### 1. Neighborhood Schools & Neighborhood Sports Leagues (Cash)

- a. Bancroft- Hosting a Fun Run and currently looking for business sponsors
- b. CMP is also hosting a fun run and looking for sponsors. CMP enrollment has wrapped up. Welcoming 47 new TK students.
- c. NCG will ask Jasjit Singh and Jose Navarro (SCUSC trustees) to join a future meeting to talk about how they're improving the process/complying with next year's requirement to offer TK at every school.
- d. CG Gators- registration is open.
- e. CGLL- season in full swing.
- f. BAC Soccer- partnering with the City of Sac to offer soccer clinics, beginning now until the soccer season starts in August.

#### 2. Sacramento Police Department (LT. Todd Bevins)

- a. Howe and La Riviera shooting- suspect was arrested and will go through judicial process now.
- b. Experiencing staffing challenges. In January, the department posted shifts for overtime from 12pm-10pm for patrol officers, several days a week. Sac PD is waiting to see if it can continue the program because of budget constraints. The city experiences the highest call volume during that time frame.
- c. Raley's stabbing- an argument started on the light rail at the 65th RT station and the victim got off at the Folsom RT station and ran to Raley's for help. Identified two suspects and the victim survived. There are cameras on the light rail.
- d. They have added a nighttime traffic enforcement team sergeant, and 3-4 dedicated officers for traffic enforcement 4 days a week, on hours not normal traffic enforcement.
