1. NCG Financial Report (Mat)

- a. 5 new members since January board meeting, totaling 265 members

F. Non-NCG Reports

1. Neighborhood Schools (Cash)

- a. Umoja- picture day is 2/25/25
- b. Bancroft- Dine out night is tonight at Fara. 20% goes back to Bancroft. Rehearsals started for Alice in Wonderland production.
- c. CMP- Received 10 million to renovate campus. 5 million is from a grant and 5 million is from SCUSD. The funds will be used to improve buildings, roofs, irrigation, the multipurpose room, and purchasing a new portable. The renovations will start next summer and completed over the course of a year.

2. Neighborhood Sports Leagues (Cash)

- a. CGLL- Opening day is March 8. Fundraiser will be on 2/22 at the Cabana Club, with a suggested donation of \$5. CGLL parade on 3/8 at 8am, going from Raley's to Occidental, to La Riviera and the baseball fields. CGLL will host a pancake breakfast and hold the opening ceremony after.

3. Folsom Boulevard Coalition (Linda)- They held their 2/12 meeting remotely. FBC working with Professor Carillo at Sac State to upgrade FBC website. Howe Ave median is targeted to be completed in late April. Project development at 8581 Folsom Blvd is no longer going forward (SSA office parking lot).

4. Sacramento Police Department (LT. Todd Bevins)

- a. Captain James Harrington attended the meeting and hopes to put together something with neighborhood leaders/neighborhood associations and business districts. Wishes to connect associations, and bring police resources to teach about sequence



of assignment, why and when they deploy SWAT, investigators, etc. Hoping to host first meeting in late spring and then quarterly from that point forward.

- b. Howe underpass at La Riviera- there was a confrontation with an unhoused person and shot was fired into the dirt as a warning. Person identified and will be in custody soon. 1 burglary occurred south of Folsom Blvd and 1 on Lake Forest.

5. California Assembly Report (Maggy Krell/Kristin)

- a. Holding a clothing drive benefiting Women's Empowerment.
- b. This coming Friday is the last day to introduce bills.

6. Sacramento City Council Report (Councilman Eric Guerra Representative)

- a. 2/18- City Council passed the Fruitridge Road Improvement Project. Phase 1 passed a few years ago and received the funds to do Phase 2. Stretches of Fruitridge will be re-paved and increase pedestrian, cyclist, and public transit safety with lane reduction, speed reduction, upgraded bike lanes, buffered bike lanes, etc.
- b. Truxel Bridge. Of the 4 designs submitted, none had a no car option. City Council voted to move forward with 3b which was the most cyclist friendly, public transit friendly option. Option 3b still includes cars but prioritizes all modes of transportation.
- c. Guerra's Office has asked for a moratorium on RV code enforcement while staff is looking at possible exceptions.

H. Information Items (Items not to be voted on)

1. Neighborhood Events

- a. Easter Egg Hunt (Leni/Steven)
 - i. 4/19 at Oki Park from 3-5pm
 - ii. Event permit has been submitted and we should hear back within a couple of weeks.
 - iii. Next month, the egg hunt committee will discuss volunteer needs and hope to have Cash spread messaging to students needing volunteer hours.



- iv. NCG will again be offering space for neighborhood vendors and booths.

2. NCG Board Meetings on Zoom (Mat/Andie)

- a. Internet access is limited at Peet's and NCG is currently paying \$17.11 a month for Zoom. Because of this and the historic low attendance rate on Zoom, we propose cancelling the Zoom subscription and using a free option if/when a member requests a video link.

3. CG Business Map (Leni)

- a. Leni will be sending out a Google form through social media and talking to businesses in the CG area. We will offer to join the business map, with a suggested donation of \$50. If enough businesses interested, Leni will pay out of pocket to purchase window clings. To be on the map, you must either conduct business in CG or live in the neighborhood. (It is okay if there is no physical business location.) Annual sponsors will automatically be on map and differentiated with a different icon.

4. Printed newsletters (Leni)

- a. Cost breakdown- options
 - i. 76 cents a copy, totaling \$2,280 for 3,000 copies. Front page color and rest all black and white.
 - ii. Leni's work printer would be 48 cents a copy, totaling \$1,400 for 3,000 copies.
 - iii. 35 cents a copy at Sac Pack and Ship, totaling ~ \$1,050 for 3,000 copies for 4 pages in color and they will fold.
 - iv. Use a postcard company Cost would be \$1,200 for 3,000 copies and they would do the mailings.
