1. Neighborhood Schools (Cash)

- a. Bancroft Fundraiser upcoming. Email PTO for more information

- c. Rio Americano's homecoming games are this Friday night, with the dance being on Saturday night.

2. Neighborhood Sports Leagues (Matt)

- a. Cabana Club Gators fall swim is wrapping up.
- b. CGLL is wrapping up fall ball. Next season is kicking off in March 2025. This will be the first year CGLL is offering girls softball.
- c. Buzzard Ball registration goes through November 16th. Boys and girls teams are divided by age (1st through 8th grade). There are usually about 1,200 kids and playoffs are held in the Kings stadium.

3. Cabana Club Updates (Ashlee)- Oktoberfest was on 10/5. Last day the club is open is Saturday 10/19. 10/20 will be a clean up day.

4. Folsom Boulevard Coalition (Linda)

- a. FBC website is live. A Sac State student is helping maintain the website.
- b. Power Inn Alliance (PIA) has a new executive director, who was previously the director at a midtown association.
- c. Project Development- the project proposed for the parking lot of the social security office has filed an entitlement to separate the parcel from the social security property. 60 days for approval. The development would be 124 units/4 story building (previously was planned for 5 stories) and the project developer is waiting for favorable financing.

5. Sacramento Police Department (LT. Todd Bevins)-

- a. **Crime stats:** frequency at the status quo
 - i. NCG requested the crime report (spanning November- November) so we can facilitate a community discussion, in conjunction with FBC/PIA.



- ii. The crime report doesn't include 311 data because the crime team doesn't have access to it. LT. Bevins will see if we can obtain 311 stats.
- iii. Patrol planning occurs at the beginning of each year. Sign-ups occur in November and officers move to their new area the first week of January. The city does look at 311 and 911 calls for resource allocation/assigning patrol units.

6. California Assembly Report (Kevin McCarty Representative)- no updates

7. Sacramento City Council Report (Councilman Eric Guerra Representative)

- a. City Council goes on recess at the end of December.
- b. Observing a general decline in 311 calls and homelessness calls.
- c. Printing signs out for under the Howe overpass and will install them in the next week or two on both sides of La Riviera. Recommended putting 5 signs on each side but code enforcement may only install 3 on each side. Similar layout will be implemented at the Watt and La Riviera underpass. The sign funding is coming from the Public Works Department budget.

G. Public Comment (Brown Act § 54954.3) *This segment of the agenda is reserved for members of the public to directly address the NCG Board on any matters within its jurisdiction. - 1. Printed newsletter distribution (Leni)-** over 2,500 households are in CG, with 25% of residents over age 55. These residents may struggle with social media access or internet savviness. Leni proposes distributing printed newsletters bi-annually (in November and spring to take advantage of better weather, and to coincide with NCG elections/timing before summer events). Commercial printing will cost around \$4,000 (Leni received quotes from 3 different printer companies.) Leni and Matt volunteer to cover the cost of paper and printing ink. Potentially consider a sponsorship for printing costs.
