1. **NCG Financial Report (Mat)**



- a. Current account balance- \$1,772.62 and doesn't include SMUD's \$750 for Halloween yet. Mat re-sent the invoice to SMUD.
- b. Filed our Business Operations Tax exemption (required every 2 years).

F. Non-NCG Reports

- 1. Neighborhood Schools & Neighborhood Sports Leagues (Cash)
 - a. CMP- raised \$30,000 in their read-a-thon. Their book fair is next month and are on Thanksgiving break all next week.
 - b. Bancroft: voted best elementary school in Sacramento for 3rd year in a row.
 - c. Miwok: 6th grade visitation days are in December and January. Visit the school website to schedule a tour.
 - d. Umoja: Partnering with Jack and Jill of America to host Cookies & Cocoa with Santa on 12/13 from 11:30-2pm. Canned food donations will also be collected.
 - e. Rio Americano: High school tours for incoming freshman are happening this week. Visit the school website to book a tour.
 - f. CGLL: registration is open for baseball and softball. Register now for early bird pricing. Prices increase on January 1st.
- 2. Folsom Boulevard Coalition (Linda)- PGE will install a temporary chain link fence around the PGE substation. Eventually, the permanent security fence will be taller than the original fence, and feature a vinyl-wrapped wall mural. The fence will be done by the end of the year and will be completed in sections. The mural will be completed in February 2026.
