E. NCG Reports

1. NCG Financial Report (Mat)

- a. NCG current account balance is at \$1,140.88.
- b. New in-kind sponsorships- Tumblebuddies and realtor, Nicole Dunlevy. (DJ for halloween event, and free ice cream coupon books for halloween treat bag, respectively.) Treasurer report received and filed.
- c. 11 membership renewals since email blast. Renewal dues are voluntary.

2. NCG Membership Status (Kristin)

- a. 5 new members since the last meeting, 2 of which signed up at the last Friday food truck event.
- b. We are looking into new ways to drive NCG website traffic. Membership report received and filed.

1. Neighborhood Schools (Cash)

- a. CMP still enrolling 4th-6th grade and interested parents can visit/check out more information online.
- b. Bancroft Dine-In night at Panera tonight until 9m. 20% of the proceeds go to Bancroft. First PTO meeting tomorrow (9/19) for Bancroft.
- c. Umoja's first volleyball game and school dance coming up.
- d. Miwok PTSO fundraising event going on, with a goal of \$6k. Donations can be made via paypal.
- e. Rosemont and Rio Americano are both prepping for homecoming week in October.

2. Neighborhood Sports Leagues (Andie)

- a. CGLL is now offering softball and will hold a clinic sometime in October. There will be an age minimum/ maximum. NCG will feature in our upcoming newsletter and social media posts, so look out for registration.
- b. BAC soccer's first games are this month.

3. Cabana Club Updates (Mat)-Currently on fall hours: Fri 5pm-10pm; Saturday 1pm-10pm; Sunday 11am-9pm. Oktoberfest will be on 10/5 and members can bring guests, but it's not open to non-members. Fall hours end on 10/19. Resurface basketball and tennis ball courts. Waitlist is 18 months.

5. **Sacramento Police Department (LT. Todd Bevins)**- Sacramento recently experienced a high number of threats at schools. Threats were received for McClatchy, Miwok, Johnson High School. Although SacPD didn't believe any of the threats were credible, they took them seriously and made 3 arrests last week in relation to the threats. SacPD is not doing any press releases or publicizing the arrests to deter copy cats, and they no longer have student resource officers actively speaking to these type of threats. However, they will perform education if schools request it.

- a. Member of the public asked what neighbors can do to report certain activities.
 - i. Presence of camp or trailers- report to 311.
 - ii. Criminal behavior that doesn't rise to the level of emergency- use the non-emergency line. The IMT team don't work 24 hours a day re: homelessness so there may be a delayed response, but using the 311 app provides a somewhat quicker response.
- b. Member of the public asked what the proposed signs under the Howe underpass will accomplish? SacPD can now enforce the citation codes on the signs. There is no finalized timeline for when the signs will be put up. Eric Guerra's office has a mock-up of signs but needs to arrange the infrastructure like digging holes for the sign posts, etc.
