**E. NCG Reports**

**1. NCG Financial Report (Mat)** - Total \$1,472.52. NCG is preparing to file taxes for 2023.

2. **NCG Membership Status (Leni)** - We currently have 215 members which is approximately 15 more than previously announced at the January meeting.

1. **Rosemont High School Report (Kristin)** - Nothing to report at this time.
  2. **Albert Einstein MS (Kristin)** - Nothing to report at this time.
  3. **Miwok MS Report (Cash)** - Airock, a lipsync dance competition, will be held tomorrow. Cost at the door is \$4.
  4. **Umoja International Academy (Cash)** - Today was the last day for school tours. Since College-Glen is within Umoja's boundaries, you may contact for a tour any time by calling the front desk.
  5. **Bancroft Elementary Report (Cash)** - TK and Kindergarten visitations went well.
  6. **California Montessori Project (CMP) Report (Andrea)** - CMP had their new swing set and sandbox installed. The swing set includes an ADA swing.
  7. **CGLL (Kyle)** - Opening day for CGLL will be on March 9. The festivities will begin with a parade from Raleys to the ballpark. After the parade, there will be a free pancake breakfast and then baseball games will commence.
  8. **Folsom Boulevard Coalition (Ashlee)** - One of the main focus points of the organization has been the multiple homeless encampment on Folsom Blvd near Brother's Plumbing. There have been multiple cleanup endeavors run by the city of the past few weeks. Another focus has been trying to set up a local farmer's market. There have been meetings with the city, and NCG to see if this can be brought to fruition.
  9. **Sacramento Police Department (Lt. Brett Myer)** - There are no updates at this time.
    - A. Kristin brought up that there have been sideshows happening in the neighborhood on the Glenbrook side. Lt. Myer said he is not to familiar with this issue and would reach out to Lt. Eaton to learn more about the sideshows happening in and around College-Glen.
    - B. Cathy asked for further information on the homeless encampment near the Howe River Access. Brett said there are limited actions

the police force can do with this. He said that you can reach out to 311 or the 311 app with reports.

- C. Cathy asked about an unhoused individual living near Bancroft. Andrea stated that this has been addressed as of this morning and the individual has been offered services. Andrea stated that she will reach out to the city for a further update.

**10. Sacramento City Council Report (City Councilmember Eric Guerra Representative, District 6)**

- a. **Update on Kiefer Boulevard and Howe Avenue Encampments** - Many people have reached out to their office about this encampment. Union Pacific has agreed to fence the area and is open to the possibility of selling the property in the future. There is now a portal on the Union Pacific website to report encampment and safety issues. Union Pacific has also given the city written permission to enter the property in regards to these issues. Services are offered to all individuals when they are met at encampments by social services. There is a new shelter with 175 spots that will open on Stockton Blvd. There is also more permanent housing opening on L Street near the Capitol. There will still be a shortage of beds with these new spaces, but we are ahead of schedule in regards to the agreement made with Measure O for more adequate housing.
