A. Call To Order (Andrea) Meeting called to order at 5:33pm.

2. Quorum (Ashlee) Quorum was met.

C. Adoption of Agenda (Ashlee) Andrea motioned to add two items to the agenda:

- Add Item F(1) Presentations: Maria from Folsom Boulevard Coalition presentation on partnering on a grant application. Removed that item from H(5). All in favor. Motion carried.
- Add Item J(b) to items to be voted on re: moving monthly NCG Community Board meetings from 5:30pm to 6pm. Andrea motioned for amending the agenda to add two items. Kristin seconded. All in favor. No dissents. Motion carried.



D. Approval of Previous Minutes from June 19, 2024 (Ashlee) *Minutes to be attached to the end of the agenda.* Ashlee motioned for approval. Andrea seconded. Motion carried.

E. NCG Reports

1. **NCG Financial Report (Mat)** NCG bank account total is at \$372.39. Mat followed up with SMUD on their outstanding commitment to sponsor Bark in the Park event for \$500. Possible new sponsor: A Board of Trustees representative from the Sac City Unified School District expressed interest in a \$150 sponsorship but we've not yet received it. Treasurer's Report received and filed.
2. **NCG Membership Status (Kristin)** - We have 7 new members since the last NCG Community Board meeting and 1 renewed membership. We expect to send out a renewal email to members before the end of the month. Membership Report received and filed.

F. Presentations

1. Folsom Boulevard Coalition (FBS): FBC continues to work towards identifying the needs of the Folsom Blvd. corridor and is looking for a partner to apply for a Sacramento Area Council Governments (SACOG) grant underneath their Engage, Empower, Implement (EEI) program. Through this grant, FBC will request funds to hire a consultant to develop a community needs assessment for the Folsom Blvd. corridor, including a clear plan regarding infrastructure and highlighting where/what's left out in traditional planning processes. This is the first year SACOG is awarding grant funding to community based organizations, with each selected organization potentially receiving anywhere from \$80,000 to \$500,000. In total, SACOG is awarding \$3.8 million in grants.

G. Non-NCG Reports

1. **Neighborhood Sports Leagues (Ashlee)**
 - a. CGLL- JUNIORS won the Section 4 Championship and went to the State Championship on July 13. MINORS won the District Championship on July 2 and advanced to Sectionals on July 11. This is the first time in the league's 50-year history that two teams have ascended to Sectionals.
 - b. **CG Gators-** Champs Rally on 7/17. Champs from July 19-21. End of Season celebration on July 22. August 3-4 is the Meet of Champions.
2. **Cabana Club Updates (Mat)** No updates.
3. **Folsom Boulevard Coalition (Linda)**
 - a. FBC is designing their website. It's currently in progress and is not yet public. They are hoping to put some of their documents on the

website and make them dynamic so residents can stay up-to-date on their endeavors.

- b. Planning developments at 8647 Folsom Blvd. (liquor store/massage parlor) and 8661 Folsom Blvd. (auto yard) are requesting a design change. There's no progress for 8581 Folsom Blvd. development (SSA building) because the developers are waiting for better interest rates.
 - c. CGNA is working on issues with Howe and Watt Ave underpasses and are requesting that signs be posted in that area saying no drug or alcohol use.
- 4. **Sacramento Police Department (LT. Tod Bevins)** LT. Bevins is on paternity leave and there are no updates.
- 5. **California Assembly Report (Kevin McCarty Representative)**
 - a. They are holding their annual backpack giveaway on 8/5/24 from 3pm-6pm and are giving out ~700 backpacks filled with school supplies. Partnering with Mayor Pro Tem Karina Talamantes. Hosting vendors serving students and children. Serving hot dogs, halal hot dogs and offering free haircuts which will be offered on a first come, first serve basis. A child does not need to be with you. They have had extra backpacks to give away in past years.
 - b. Finalized date for upcoming town hall. It's on 8/13/24 at B Street Theater from 6pm-7pm and will share the flyer soon. Assemblymember McCarty will be available to ask questions.
- 6. **Sacramento City Council Report (Councilman Eric Guerra Representative)** Their office is on recess. No updates.

H. Public Comment (Brown Act § 54954.3) *This segment of the agenda is reserved for members of the public to directly address the NCG Board on any matters within its jurisdiction. A time limit of two (2) minutes per speaker and ten (10) minutes per topic will be allotted. No action may be taken during this time. NCG may briefly respond to comments made or questions posed. I. Information Items (*Items not to be voted on*)

- 1. Fourth of July Recap (Andrea)** It's technically the 5th year the parade's been held, but it's only the 2nd year since NCG's formal inception. The event was from 11am-1pm, and participants paraded from the Cabana Club to Oki Park. Even though it was ~105 degrees outside, roughly 300 people enjoyed the event. We went over our budget by \$50, but ultimately made \$100 from the event because we collected \$150 in vendor booth fees. We're looking for ways to improve traffic control for next year. Select roads were closed for less than an hour, but some



residents ignored the road closure signs and drove past/around the barricades. We're debating moving the time to earlier in the morning because of the heat. In the past, the event was from 10am-12pm but then we moved the time back to accommodate a community partner's availability.

2. **Summer Food Trucks (Leni)** The July food trucks were canceled because of heat, but the August food trucks are still slated to go forward. The August event will have 5 food trucks: gyros, Mexican, donuts, pizza, and Indian food. 50 Corridor TM loved being at the June food trucks so they're coming back in August. NCG will be reaching out to local schools to see if they want to host a booth at the August food trucks. 3. **National Night Out (Kristin)** - Tuesday 8/6 is National Night Out. Annually, it's the first Tuesday of every August and it's a chance to meet neighbors. If you register through the official National Night Out website, you can expect local law enforcement to show up. Glenville Circle won't be hosting a National Night Out this year but NCG is happy to help advertise and notify neighbors if a National Night Out event is occurring elsewhere in the neighborhood. 4. **Upcoming Events (Steven): Movie Night & Safe & Sweet Trunk or Treat)**
 - a. 9/13 Oki Park Movie Night: There will be food trucks and NCG will host a booth selling candy. TBD on the movie showing, but we'll share that info once it's confirmed.
 - b. 10/31 Safe and Sweet Trunk or Treat: We're still trying to solidify a location for this year but there will be trunks, vendors, music, and activities.
5. **Streets for People (Andrea)** 4 NCG Board members attended a focus group put on by a city initiative to improve active transportation in Sacramento. Active transportation includes anything involving human movement (e.g. walking, biking, scootering, etc.) The focus group aimed to hear directly from residents about ways to improve movement in our community and make active transportation safer. The city is currently in Phase 2 of the project which involves engaging directly with the community. NCG featured the Streets for People initiative in its July newsletter and we'll be advocating for engagement on various social media platforms. The city is requesting feedback on an interactive map through 8/11. Hopefully significant engagement from the College-Glen



community results in funding to address identified issues in our area. Many issues have to do with speed on La Riviera and Folsom Blvd and safer areas to shop, etc. The Streets for People provided some discussion questions to prompt residents' feedback: 1) Are there any destinations you typically travel to that are not shown or connected in the map? 2) In the context of your neighborhood, are the routes shown on the map ones that you would use to get to where you need to go? If not, what route(s) would you prefer to take? 3) Do you have any recommendations not currently on the map? You can "like" other community members' suggestions on the interactive map to show interest/support. Additionally, think about the pending developments along Folsom Blvd. and how they could be impacted or benefit from this initiative.

J. Action Items (*Items to be voted on.*)

1. **Engage Empower Implement Grant Application.** Andrea motioned to move forward with partnering with FBC on this application, provided that FBC completes the application and is not asking for more than \$100,000 in grant funding. Kristin seconded. Roll call vote: all in favor. No dissents. Motion carried.
2. **NCG Community Board meeting time change:** Changing start time from 5:30pm to 6pm, and keeping end time at 7:00pm. Andrea motioned for approval. Mat seconded. Roll call vote: all in favor. No dissents. Motion carried.

K. Adjournment Meeting adjourned at 6:32pm. Andrea motioned to adjourn. Mat seconded.
