F. Non-NCG Reports

1. Neighborhood Schools & Neighborhood Sports Leagues (Cash)

- a. BAC Soccer: looking for next year's board members. There are many positions available. Reach out to the club manager for more information if interested.
- b. Bancroft: Spooky Saturday is Oct 25th from 3-6pm. This is Bancroft's fall festival and is open to the community. Volunteers are needed to help with games. If interested, please reach out.
- c. CMP: Read-a-thon starts Monday and goes through Nov. 3rd. CMP also met with an architect for the school renovation. Every classroom will receive new floors and paint and a new HVAC system will be installed in the multipurpose room. All new landscaping with a community space is planned, although they will lose 8 fully grown trees because of needed utility work. There is currently a proposal to the board to add 6 new classrooms and renovation work is expected to go from April-August 2026.
- d. Umoja: the last day to donate to Umija's school drive is Friday October 24th.
- e. Miwok: still in need of help with crosswalk duty. If interested, please contact Miwok's office manager.
- f. Rosemont: next PTSA meeting is tomorrow at 6pm in the large conference room.
- g. Rio: they are beginning to explore improvements to their stadium. Future plans include a press box, lighting, a sound system, and bleachers.

2. Folsom Boulevard Coalition (Linda)

- a. CGNA annual meeting is Oct 16th at the fire station.
- b. PGE fencing is coming along, with the mural most likely completed in early 2026.
- c. The project behind the SSA building is going again, with 1 year expected for the design/planning/permit portion, and another year for the actual build. The project would entail 124 units.

3. Sacramento Police Department (LT. Todd Bevins)

- a. Car thefts are trending (3 in the last week) on Bicentennial and La Riviera.
- b. Seen more safety concerns in the Raley's shopping center (2 incidents in the last month).



- c. Sac RT police is going through a staffing shuffle, with some officers leaving RT to increase patrol units because patrol is currently understaffed. Once the officers leave Sac RT, Sac PD will no longer have any involvement in RT but county sheriff's deputies will continue monitoring it. These staffing allocation changes will occur in mid-December.

1. Neighborhood Events

- a. **Halloween Safe and Sweet Trunk or Treat (Linda/Cathy):** 11 trunks, plus SacPD, Sac Probation Dept. and the Fire Dept. attending. TumbleBuddies is providing a DJ and 5-6 games are planned. There will be no food or vendor sales. Still need volunteers for set up, breakdown, and game attendants.
- b. **Holidays in College-Glen (Ashlee/Kristin):** will be held Dec 7th at CMP, from 10am-1pm. We're essentially hoping to replicate last year, including hot chocolate, a few festive crafts/activities, pictures, and various local crafters/artisans. We'll put a call out to vendors soon but already seeing some interest from vendors.

- a. Holidays in College-Glen budget: \$500 for marketing, incidentals, craft activities, and complimentary beverages provided. Kristin motioned for approval. Linda seconded. All were in favor. Motion carried.
