- 2. Quorum (Ashlee) Quorum was met.
- **C.** Adoption of Agenda (Ashlee). Agenda adopted as amended. Andrea motioned to amend item G6 on agenda to reflect "councilmember." Ashlee seconded. All present board members assented to the amended agenda being adopted. No dissents. Motion carried.

**D.** Approval of Previous Minutes from March 20, 2024 (Ashlee) Minutes to be attached to the end of the agenda. Ashlee motioned for adoption of previous month's minutes. Leni seconded.

#### E. NCG Reports

- 1. NCG Financial Report (Ashlee in Mat's stead) Currently \$2,003.95 in NCG account. Our annual registration renewal, annual treasurer's report, and raffle registration all submitted to the Department of Justice this past month. SMUD committed to a \$1,500 sponsorship package where they will pay \$500 for Bark in the Park, Safe and Sweet Trunk or Treat, and Holidays in College-Glen after each respective event is held.
- 2. NCG Membership Status (Kristin) New goal is for membership to reach 25% of the ~3,000 homes in NCG's boundaries by the end of the 2024-26 NCG Board term.
- F. Presentations This segment of the agenda is reserved for individuals or organizations to directly present information to the NCG Board on any matters within its jurisdiction. #### a. Folsom Boulevard Coalition (Maria Gutierrez)

i. Sac State students created an economic development plan for the Folsom Boulevard corridor, with the goal of revitalizing Folsom Boulevard and providing a framework for improvements in safety, accessibility, and mobility. The plan also identifies potential organizations to partner with in creating art and cultural attributes to highlight the significance of the Folsom Corridor. The economic development plan was created with the intention to apply for funding through the CalTrans Community Based Transportation Planning Grant and the Offices of Art and Culture.

## G. Non-NCG Reports

#### 1. Neighborhood Schools (Kristin & Cash)

- -Bancroft's Beaver Dash is 4/19 and their next PTO meeting is 5/1 at 6:30pm in the cafeteria. Dine Out fundraiser on 4/19 from 12pm-10pm at Menchies. A percentage of sales goes to Bancroft.
- -Miwok's softball team just won the city championships and their PTSO fundraiser and silent auction will be at Sac Yard on 4/20 from 1pm-4pm. It's family friendly.

### 2. Neighborhood Sports Leagues (Cash)

-CGLL regular season games start 4/23 and their crab feed fundraiser is on 4/27 from 5:30pm-11pm. Tickets are on sale now. CGLL home run derby is on 4/21 from 10am-1:30pm.

- -CG Gators already have over 200 swimmers registered and practices start 4/22, with the first swim meet on 5/11.
- -BAC's early registration is open until 5/31 and late registration starts on 6/1. Payment plans are available.
- **3.** Cabana Club Updates (Mat)- 60th Anniversary Party on 4/26. 60's themed and open to non-members. Adults only. Tickets \$50.
- 4. Folsom Boulevard Coalition (Kristin in Ashlee's stead) FBC received grant by Assemblymember Kevin McCarty's office and they will use that funding for a mural on the PGE's powerstation wall once it's installed later this year. FBC will work with Sac State students in a historic design class and the students will be tasked with community engagement to talk to the community, discover our district's history, and come up with potential artwork. The students will then meet with a professor in spring 2025 and present the gathered info/art designs. The mural will be installed as vinyl wraps, similar to the art on the utility boxes along Folsom Blvd.
- 5. Sacramento Police Department (LT. Zack Eaton)
  - -Crime Report for the College-Glen area, March 2024: 2 domestic violence incidents, 2 stolen vehicles, 2 thefts from vehicle, and 1 residential burglary. All but 2 happened in the apartments on Howe. If we filter out the Howe apartments, then only 1 domestic violence incident and 1 stolen vehicle report off of La Riviera.
  - -2 suspects from homicide at 65th and light rail station are in custody as of last week. The 2 suspects were identified the same night of the homicide.
  - -Pebble trail-the property owner informed tenants they have until May to vacate the house. If that doesn't happen, then will work with Justice for Neighbors.
  - -Incident at the LDS church this weekend. Detectives are going to follow up and develop strategies to identify the kids involved and contact parents.
  - -LT. Eaton is being moved to south Sacramento, so a new area LT is being assigned to District 7 (College-Glen) in two weeks. The new LT Lives in D7 and LT. Eaton will send his info..
- 6. Sacramento City Council Report (Councilmember Eric Guerra Representative) No formal announcements. Food trucks are starting next month and go through August, from 5pm-7pm every second Friday. SactoMofo will bring musical talent and Sacramento Optimist Club will host a beer garden.
- 7. California Assembly Report (Kevin McCarty Representative)

-Member of the public advised the NCG website was not working and noted the QR code on NCG's April newsletter was not working as well. Andrea stated it'll be looked into and NCG is currently transitioning its email and other digital platforms.

  - 1. Bark in the Park (Kristin) Bark in the Park will be on 5/25 from 10am-12pm at Glenbrook's large dog park. Multiple vendors will be there, including SSPCA, SMUD, and a sponsored doggy kissing booth. Event is okay for teenagers to volunteer at and we need about 6 volunteers. - J. Action Items (Items to be voted on)
  - a. Approval of Bark in the Park budget Budget is \$500 which includes ~\$300 for permit, and funding for giveaways, banners, and additional marketing materials. SMUD's sponsorship will reimburse these costs after the event. Kristin motioned to approve the \$500 budget. Leni seconded. All present board members assented. No dissents. Motion passed.
