E. Presentations

1. **Isaac Gonzales- Slow Down Sacramento**

- a. Focuses on reducing vehicular violence through policy changes and changes to roads, including speed reductions.



- b. City hall recently passed a “quick-build” program which allows changing the environment and roads in a more expedient manner. Ex: Use of vertical delineators, rubber curbs, pots or big planters to narrow streets, temporary roundabouts, etc.
- c. “20 is plenty” goal of reducing neighborhood speeds to 20 mph. Statistics show survival rate for accidents increases exponentially with this speed reduction.

1. NCG Financial Report (Mat)

- a. Current balance is \$2,559.05
- b. Received Bark in the Park \$750 from SMUD.
- c. Treasurer report received and filed.

2. NCG Membership Status (Kristin)

- a. 2 new members since August board meeting
- b. Membership report received and filed.

G. Non-NCG Reports

1. Neighborhood Schools & Neighborhood Sports Leagues (Cash)

- a. CMP- recently awarded for their success in Positive Behavior Interventions and Support.
- b. Bancroft- Fall festival and Spooky Saturday is 10/25 and open to the community. It runs on volunteers and there are many opportunities for high school students to earn volunteer hours.
- c. Miwok- 9/26 is their first Spirit Day and back to school dance. They are looking for help with crosswalk duty before and after school.
- d. Umoja- Hosting a shoe drive, collecting new and used shoes between now and 10/17 to support the school and those in need. Anyone can donate at the collection bins on campus.
- e. Rio Americano- Until 9/26, they are collecting backpacks and school supplies for students with limited resources. Donations can be brought into the counseling office.
- f. Rosemont- Homecoming is 10/3, starting with their annual homecoming parade at 3:45pm, followed by the game and dance.

2. Folsom Boulevard Coalition (Linda)

- a. FBC added their master plan to website sacramentofbc.com
- b. The Folsom Blvd. PGE substation fencing and landscaping removed and the fence installation is scheduled. Hoping for mid-November for the new landscaping completion.



- c. There will be a District 6 and FBC meeting with Folsom Blvd. businesses between Howe and Watt on Oct 17th from 9:30am-11:30am.

3. Sacramento Police Department (LT. Todd Bevins)

4. Sacramento City Council Report (Mayor Pro Tem Eric Guerra Representative)

- a. City Council heard an item about moving to a 2-year budget cycle. The city would still pass a budget annually but the scope would be 2 years.
- b. ADU workshop heard to potentially make it easier to obtain permits for ADUs such as using an approved catalogue of models.
- c. Consent item- a letter of intent to establish a new sister city with the city of Morelia in Michoacan in Mexico. Michoacanos make up the largest demographic of Mexicans in the city of Sacramento. A sister city creates a diplomatic relationship where we can pass funds to one another for disaster recovery and urban search and rescue, create university exchange programs, connect global resources, etc. Recently re-established a direct flight from Morelia to SMF. Sacramento currently has 12 sister cities and with the 2 most active in China and Japan.

H. Information Items (*Items not to be voted on*)

1. Neighborhood Events

- a. Oki Park Food Trucks- recap (Steven)- Overall food trucks were successful and worth pursuing with the city, however we will reevaluate the July date because of heat.
- 2. **Halloween Safe and Sweet Trunk or Treat (Linda/Cathy)**-Event will be the afternoon of 10/31 at the same location as last year. We are essentially hoping to replicate last year, but with more trunks.
- 3. **September Retreat Recap- (All)**- Voted to not do the 4th of July Parade next year because the board doesn't have the capacity and we're lacking volunteer engagement.
- 4. **Sponsorship levels**- Transitioning from 3 sponsorship levels to 2, including an annual sponsorship of \$400 and neighborly sponsor of \$50.

- a. Sponsorship Levels- Leni motioned to approve the new sponsorship package. Ashlee seconded. Roll call vote: all were in favor and motion carried.
