- 2. Quorum (Ashlee) Quorum was met.
- **C.** Adoption of Agenda (Ashlee) Ashlee motioned to add agenda item regarding flag distribution. Kristin seconded. Motion passed.
- **D.** Approval of Previous Minutes from April 17, 2024, and May 15, 2024 (Ashlee) *Minutes to be attached to the end of the agenda.* Ashlee motioned to approve. Mat seconded. All board members in favor, no dissents. Motion passed.
- **E.** Special Acknowledgment: Juneteenth (Leni) June 19th or "Juneteenth" is a very important day in history. It was on June 19, 1865, that Union soldiers landed in Galveston, Texas with news that the war had ended and that all slaves were free. On June 15, 2021, the U.S. Senate unanimously approved the bill that makes



Juneteenth a legal public holiday. On June 17, 2021, President Biden signed into law Senate Bill 475 (S. 475) making "Juneteenth" a federal holiday.

## F. NCG Reports

- NCG Financial Report (Mat) NCG account has \$1,013.39 and is pending SMUD sponsorship payment for Bark in the Park. Our grant application did not get selected for the City of Festivals grant this year but we will keep exploring other funding avenues and will reapply if the City of Festivals grant is offered again in the future. Bark in the Park was a profitable event and raised \$251.31 because of the raffle. Treasurer Report received and filed.
- 2. NCG Membership Status (Kristin) 7 new members since the last NCG Community Board meeting and we are currently at 237 members. Food trucks at Oki Park appear to be a big membership driver. Members should expect to receive an email soon about renewing voluntary membership dues of \$25 annually. Membership Report received and filed.

### **G.** Non-NCG Reports

### 1. Neighborhood Schools (Kristin)

- a. Bancroft's Summer Matters Program for education retention is beginning. It's split into half day educational, and half day free play for kids entering 1<sup>st</sup> through 6<sup>th</sup> grade. Starts on 6/24 so be cognizant that parents are still driving kids to school, and kids are still walking to school.
- b. Umoja is offering a free summer school program for 7<sup>th</sup> and 8<sup>th</sup> graders to get used to transitioning to junior high. Starts 6/24 and runs through July.

#### 2. Neighborhood Sports Leagues (Andrea)

- a. Swim season is in full swing. Swim meets are generally 7am-1pm so expect traffic around the Cabana Club during that time. Come out to support our CG Gators. They have moved practices to the morning time so they don't affect the Cabana Club's summer operating hours.
- b. BAC Soccer registration ends at the end of month for the regular rate. After 6/30, it's the late registration amount. BAC will join us at the next food truck event and host a cleat and uniform swap.
- c. CGLL continues to be successful in pursuit of the championship game.
- **3.** Cabana Club Updates (Mat) Cabana Club summer hours began 6/14. The club is open 7 days a week: Sundays 11-9pm, Mon-Thurs from 1-9pm,



and Fri/Sat from 1-10pm. Spraktacular is on 6/29 and open to members only. Doors open at 1pm.

**4. Folsom Boulevard Coalition (Andrea)** No significant updates but will circulate any updates as we receive them.

#### 5. Sacramento Police Department (LT. Tod Bevins)

- **a.** No news in College-Glen for the last 10 days, so nothing new to report.
- **b.** Only issue is that someone tried to take a motorbike in the Raley's parking lot and that individual was arrested the next day and taken into custody. The individual has since been released and is known to frequent that area.
- **c.** There were no burglaries, vehicle thefts, or break-ins reported. There was one homicide in District 7 but that was south of Highway 50.
- d. Sideshow media put out by the Sacramento Police Department-An Officer was assigned to a temporary position for sideshow activity response and is monitoring the people involved in the behavior. No sideshows have recently popped up. They were concerned about one happening last week but it didn't happen. The sideshow participants are getting more savvy about posting when they will happen. That temporary position reverted to a regular assignment that was just created. The posting for the assignment is out now.

# 6. Sacramento City Council Report (Councilman Eric Guerra Representative)

- a. Easement across from Oki Park was cleaned up. Collaboration between the City of Sacramento, SMUD, and the private entity owning the parcel. Mowing/discing schedule can be accelerated if it grows back faster than anticipated. Continue to use 311 to report concerns re: the easement.
- Sacramento City Council report. Passed the budget two weeks ago for incoming FY. Balanced the budget without having to lay off anyone or cut major programs due to budget deficit.
- c. Received Point in Time (PIT) count numbers. The PIT count is a federally mandated census of the unhoused population that occurs every other year. Sacramento County saw a 29% decrease overall in homelessness: 41% decrease in Sacramento County, 31% in City of Sacramento. Also saw massive decreases in target populations of families, veterans, and those chronically unhoused.



- H. Public Comment (Brown Act § 54954.3) This segment of the agenda is reserved for members of the public to directly address the NCG Board on any matters within its jurisdiction. A time limit of two (2) minutes per speaker and ten (10) minutes per topic will be allotted. No action may be taken during this time. NCG may briefly respond to comments made or questions posed. - I. Information Items (Items not to be voted on)
  - 1. Regional Park Updates (Kristin) Easement areas across from Oki Park and Glenbrook Park were disced Monday and Tuesday of this week, so the high grass cut has been cut. Prior to Bark in Park, the weedy hill next to the dog park was disced. Park service on top of this as we enter the summer months and fire season. Right now, these areas are only scheduled for mowing or discing 3-4 times a year. Our Park Commissioner advises the best way to advocate for these areas is by attending the Parks and Community Enrichment Commission meeting which is generally held at 5:30pm every first Thursday of the month at City Hall. The budget was reduced for weed abatement so the city is mowing, but is not doing more detailed work like weeding or planter boxes.   - 2. Fourth of July planning status (Andrea) Finalizing some backend planning. We will parade from the Cabana Club to Oki Park where we will be met by vendors and Kona Ice. Firestation16, Sacramento County Probation Honor guard, and the Sacramento Sirens Cheer team will participate in the parade. A number of NCG sponsors will host booths and activities at Oki Park and we will have face painting. We are within budget and don't expect to exceed the \$850 budget. There will be a rolling street closure, closing down Lake Forest for the entire length of the parade from Notre Dame to Everglade. We will have barricades and road detour signs. Eric Guerra is also joining us.
  - 3. Summer Food trucks (Leni)
    - **a.** 6/14 Recap: Food trucks are going well and neighbors have voiced appreciation that they're back. There were 5 trucks that offered a good variety at the June food trucks. We did not have live music but sound was provided by SactoMoFo. There was a good turn out from different groups and partners, including Work of Art which is a nonprofit in the Folsom Blvd. shopping center near Raley's. Work of Art recently became a business member of NCG. Richard



Deshmond from the County Board of Supervisors had representation there and may be present at the August food trucks as well. Leni will confirm.

- b. 7/12: There will be no music for the upcoming July food trucks so Leni will put out a call asking for a free music performer. There will be 5 trucks at the July event: burgers, gyros, shaved ice, and a taco food truck. Leni's goal is to bring more awareness to the Glenbrook side of the neighborhood. We were cleared by the City to display a-frame signs at Glenbrook Park. Martial Arts Kids Club will put on a demonstration and BAC Soccer will have a cleat and uniform drive at the July food trucks as well. - 4. City of Sac Streets for People (Ashlee) The City of Sacramento Department of Public Works: City's effort to improve the active transportation network with the City of Sacramento Streets for People Active Transportation Plan. A virtual meeting will be held on July 16 from 12:00pm-1:30pm. The meeting is open to the public so residents and neighbors in the area can join in on the conversation. They will be discussing recommendations to connect the area around CSUS, including Campus Commons, College Glen, Tahoe Park, Elmhurst, Sierra Oaks, Power Inn and East Sacramento neighborhoods to the citywide active transportation network.
- 5. Flag distribution (Kristin) It's the 15<sup>th</sup> year realtor Doug Reynolds and mortgage lender Matt Gouge will distribute flags to the 2,000 plus homes in College-Glen. They need 8-10 more volunteers to help with flag distribution. If interested, meet at Glenbrook Park at 9am on 6/29. You can distribute the flags at your own leisure and it usually takes about 45min-1hr to distribute them. Contact Doug or Matt if interested. Their contact information was also in our June newsletter.
- **J.** Action Items (Items to be voted on)
  - a. *\$80 Quickbooks renewal (Mat)* Leni motioned for approval. Mat seconded. Roll call votes. All in favor, no dissents. Motion carried.
- **K.** Adjournment Ashlee motioned to adjourn. Mat seconded. Meeting adjourned at 6:30pm.
